A – Design-Build Government Acceptance of Design Submittals Design-Build

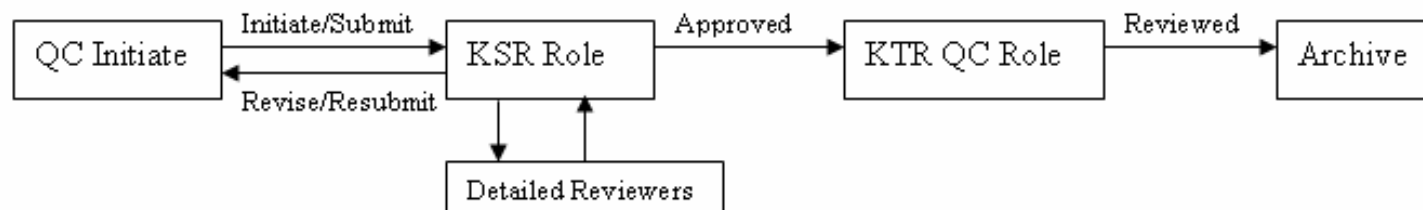

Design-Build

- A – Design-Build Government Acceptance of Design Submittals, KSR Approval of Construction Submittals
 - Design Submittals for QC Certification, KSR Approval, Government Acceptance (01331 A codes)
 - Contractor QC will initiate/submit to the KSR for approval. KSR comments will then go to QC to review and archive. Archiving will be the government's acceptance if no comments are issued in separate correspondence.
 - Construction Submittals for QC Certification and KSR Approval (Div 02-16 G Code)
 - Contractor QC will initiate/submit to the KSR for approval. KSR comments will then go to QC to review and archive.



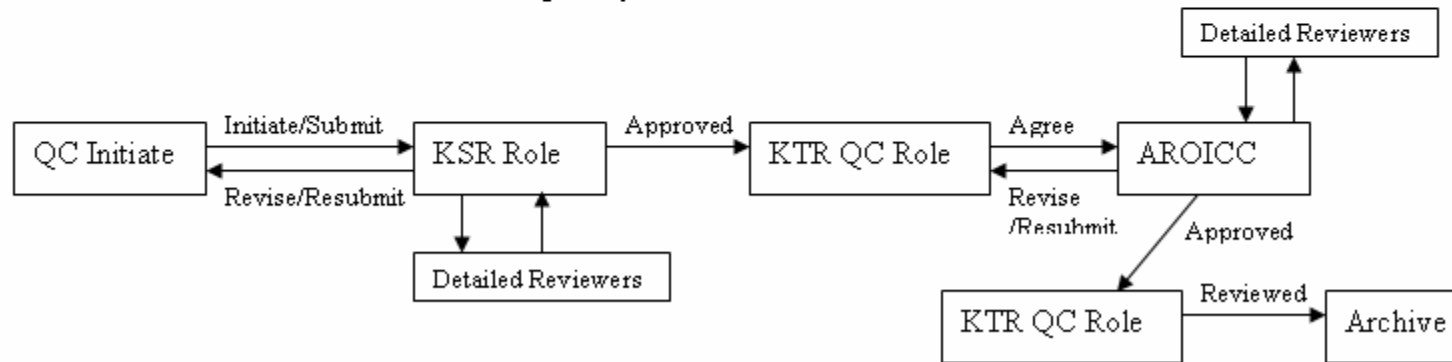

D – Design-Build Government Approved Design-Build

- D – Design-Build Government Approved
 - Design Submittals for QC and KSR Certification, Government Approval (01331 G Codes; e.g. Fire Protection Designs, Record Documents)
 - Contractor QC will initiate/submit to the KSR for Certification. KSR's comments will go to the QC for review and submission to the AROICC. AROICC will receive submittals and can send to detailed review (FEC/EIC reviewers), receive back and issue comments/approval. AROICC comments will then go to QC to review and archive.
 - Construction Submittals Reserved for Government Approval per 01332 (requires QC and KSR Certification) (e.g. Fire Protection Shop Drawings; Pad Mounted Transformers)
 - Contractor QC will initiate/submit to the KSR for approval. KSR's comments will go to QC for review and submission to the AROICC. AROICC will receive submittals and can send to detailed review (FEC/EIC reviewers), receive back and issue comments/approval. AROICC comments will then go to QC to review and archive.

C – Quality Control Contractor Approved Design-Build

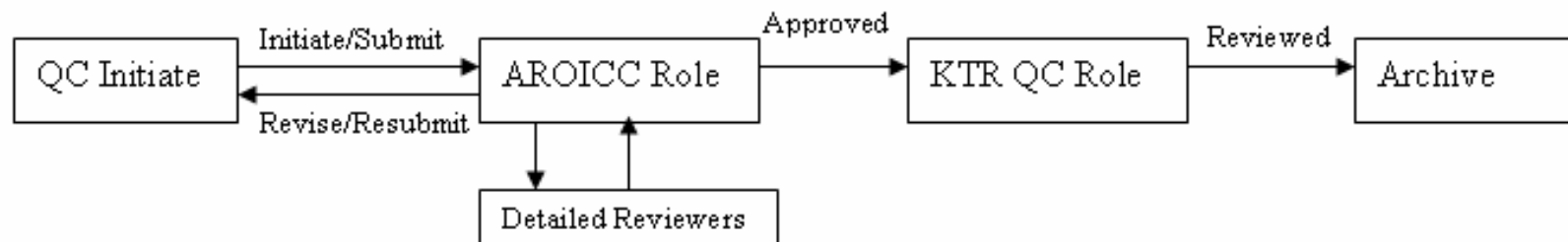

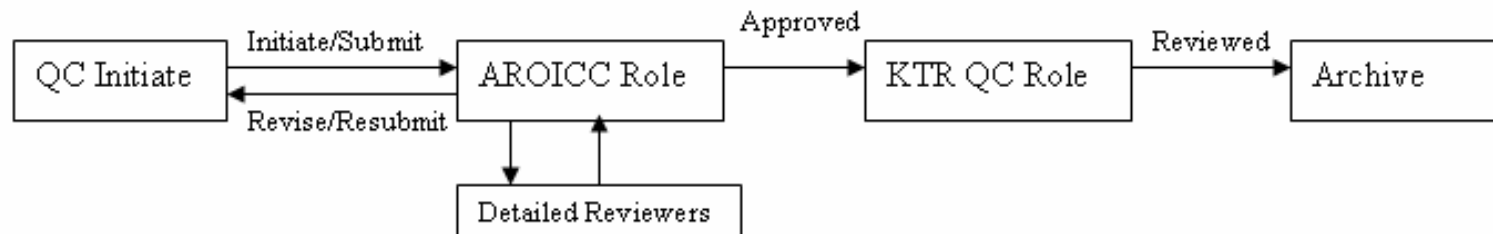

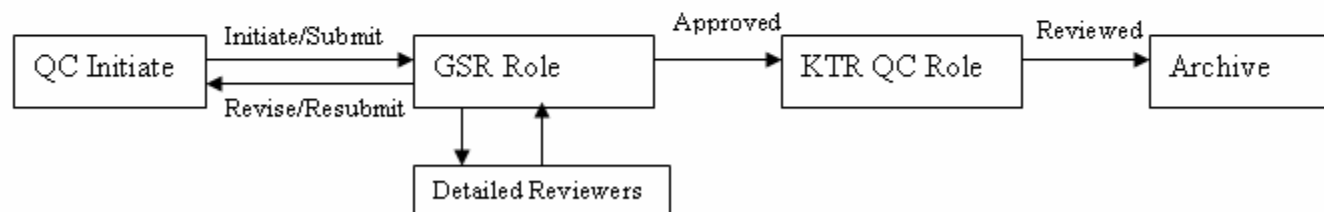

 - Contractor QC will initiate/submit to the AROICC for approval. AROICC will receive variation request and can send to detailed review (FEC, client reviewers), receive back and issue comments/approval. AROICC comments will then go to QC to review and archive.

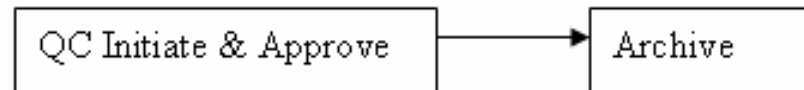

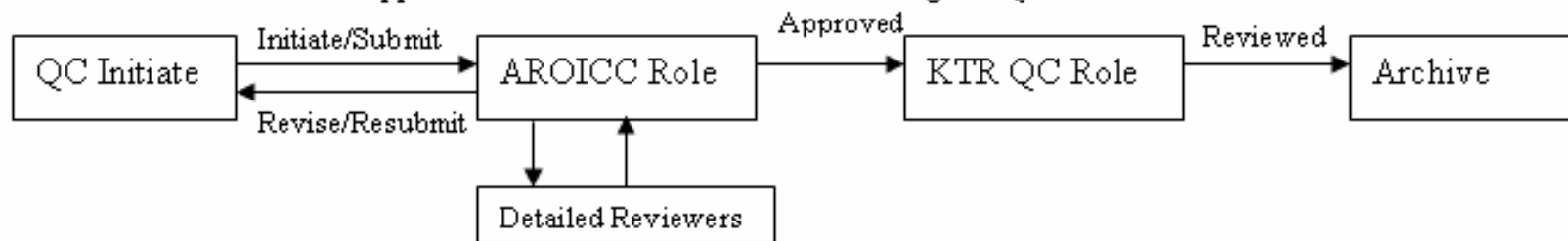

 - Contractor QC will initiate/submit, approve, and archive the submittal in one step.



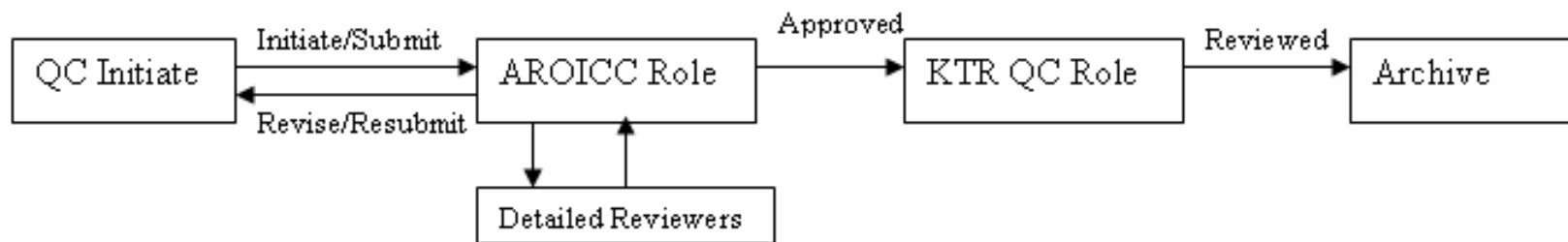
G – Government Approved Design-Bid-Build
